



## TICKETS:

### ON BOARD TICKET (Adult)

» **Municipal €2,00/ Intermunicipal €2,60**

Valid on the trip of purchase. Allows a single journey.

The price is based on the number of fare zones.

### ON BOARD TICKET (Children)

» **Municipal €1,00/ Intermunicipal €1,30**

For children aged from 6 and 12 years old. Valid on the trip of purchase. Allows a single journey.

The price is based on the number of fare zones.

### PREPAID TICKET (Adult) <sup>(1)</sup>

**Municipal €1,45 / Intermunicipal €1,95**

A transport ticket purchased and top up onto the respective GIRO support card (ticket or pass), in sets of at least two trips, prior to the trip, where each trip entitles the holder to an unlimited number of journeys that do not exceed the fare zones for which it was purchased, provided that the respective validations are carried out within 45 minutes for municipal transport tickets, or 90 minutes for intermunicipal transport tickets, after the initial validation of the trip, on regular public service routes, except the Aerobus service, operated by any Operator in the RAM.

### PREPAID TICKET (Children) <sup>(1)</sup>

**Municipal €0,75 / Intermunicipal €1,00**

Eligible transport ticket for children aged from 6 to 12 years old (inclusive), purchased and top up onto the respective GIRO ticket or pass, in sets of at least two trips, prior to the trip, where each trip entitles the holder to an unlimited number of journeys that do not exceed the fare zones for which it was purchased, subject to the respective validations being carried out within 45 minutes for municipal transport tickets or 90 minutes for intermunicipal transport tickets after the initial validation of the trip, on regular public service routes, except the Aerobus service, operated by any Operator in the RAM.

<sup>(1)</sup>The GIRO Ticket card is paid only in the first purchase and it costs €0,50. All GIRO Tickets are not personalized because they can be transferable. However, once on board, each passenger must have one. Keep it, don't throw away, you can recharge it with more journeys.

### SOCIAL PASS BASE » **Municipal €30/ Intermunicipal €40**

Individual monthly pass valid for residents and equivalent residents of the RAM. Valid for routes that do not exceed the fare zones for which it was purchased. Allows unlimited travel, on regular public service routes, except the Aerobus service, operated by any Operator in the RAM.

Submit a copy of the following documents:

- Civil identification card or passport;

- Portuguese tax identification;
- Proof of address in the Autonomous Region of Madeira (1).

Passengers up to 30 years of age, with address outside of RAM, whose proven that are traveling to RAM for volunteering promoted by services of the Regional Government of Madeira, for the duration of the same, are also considered eligible.

### SOCIAL PASS 4\_23 » **Municipal/ Intermunicipal Free**

Individual monthly pass valid for residents and equivalent residents of the RAM. Valid for students enrolled in an educational establishment of the RAM, or resident in RAM and proven to be enrolled in any official educational establishment, up to and including 23 years old. Valid for routes that do not exceed the fare zones for which it was purchased. Allows unlimited travel, on regular public service routes, except the Aerobus service, operated by any Operator in the RAM.

Submit a copy of the following documents:

- Civil identification card or passport;
- Portuguese tax identification;
- Declaration from the education institution confirming that the student is enrolled in the current academic year, it may be exempt from presentation when the ticketing system allows it to be obtained automatically;
- In the case of students enrolled in an educational establishment outside RAM, it is necessary to present the proof of address in the Autonomous Region of Madeira (1).

Students with address outside of RAM whose proven that are traveling to RAM for an internship, volunteering promoted by services of the Regional Government of Madeira, exchange or Erasmus program, are also considered eligible, for the duration of the internship, volunteering, exchange or Erasmus program. They are subject to the presentation of documentation and this proof, with the exception of the proof of address in RAM.

### STUDENT SOCIAL PASS +23 » **Municipal €22,50/ Intermunicipal €30**

Individual monthly pass valid for residents and equivalent residents of the RAM. Valid for students aged from 24 and 25 years old, enrolled in an educational establishment of the Autonomous Region of Madeira (RAM), or resident in RAM and proven to be enrolled in any official educational establishment. Valid for routes that do not exceed the fare zones for which it was purchased. Allows unlimited travel, on regular public service routes, except the Aerobus service, operated by any Operator in the RAM.

Submit a copy of the following documents:

- Civil identification card or passport;
- Portuguese tax identification;
- Declaration from the education institution confirming that the student is enrolled in the current academic year, it may be exempt from presentation when the ticketing system allows it to be obtained automatically;
- In the case of students enrolled in an educational establishment outside RAM, it is necessary to present the proof of address in the Autonomous Region of Madeira (1).

Students with address outside of RAM whose proven that are traveling to RAM for an internship, volunteering promoted by services of the Regional Government of Madeira, exchange or Erasmus program, are also considered eligible, for the duration of the internship, volunteering, exchange or Erasmus program. They are subject to the presentation of documentation and this proof, with the exception of the proof of address in RAM.

### **SOCIAL PASS +65 » Municipal/ Intermunicipal Free**

Individual monthly pass valid for residents and equivalent residents of the RAM, aged 65 years old or over. Valid for routes that do not exceed the fare zones for which it was purchased. Allows unlimited travel, on regular public service routes, except the Aerobus service, operated by any Operator in the RAM.

Submit a copy of the following documents:

- Civil identification card or passport;
- Portuguese tax identification;
- Proof of address in the Autonomous Region of Madeira (1).

### **FORMER COMBATANT SOCIAL PASS » Municipal/ Intermunicipal Free**

Individual monthly pass valid for residents and equivalent residents of the RAM. Applicable to former combatants, or their widowers, holders of the card defined in articles 4 and 7 of the Statute of the Former Combatant, currently regulated by Ordinance No. 210/2020, of 3 September. Valid for routes that do not exceed the fare zones for which it was purchased. Allows unlimited travel, on regular public service routes, except the Aerobus service, operated by any Operator in the RAM.

Submit a copy of the following documents:

- Civil identification card or passport;
- Portuguese tax identification;
- Proof of address in the Autonomous Region of Madeira (1);
- Former combatant or widowers former combatant card.

### **DISABILITY 0 SOCIAL PASS » Municipal/ Intermunicipal Free**

Individual monthly pass valid for residents and equivalent residents of the RAM. Applicable to passengers who are beneficiaries of a disability pension due to permanent incapacity for work, whose proven average monthly income is equal to or less than 54,15% of the value of the social support index (currently 282,93€ per month). Valid for routes that do not exceed the fare zones for which it was purchased. Allows unlimited travel, on regular public service routes, except the Aerobus service, operated by any Operator in the RAM.

Submit a copy of the following documents:

- Civil identification card or passport;
- Portuguese tax identification;
- Proof of address in the Autonomous Region of Madeira (1);
- Copy of the last income tax return and respective payment note or declaration issued by the competent services of the Tax Administration attesting the exemption from filing the income tax return of the household taxpayers;
- Document proving of any of the following social benefits:
  - i. Disability pension;
  - ii. Social disability pension;
  - iii. Social Inclusion Benefit.

### **DISABILITY I SOCIAL PASS » Municipal €11,35/ Intermunicipal €15,15**

Individual monthly pass valid for residents and equivalent residents of the RAM. Applicable to passengers who are beneficiaries of a disability pension due to permanent incapacity for work, whose proven average monthly income is equal to or less than the value of the social support index (currently 522,50€ per month). Valid for routes that do not exceed the fare zones for which it was purchased. Allows unlimited travel, on regular public service routes, except the Aerobus service, operated by any Operator in the RAM.

Submit a copy of the following documents:

- Civil identification card or passport;
- Portuguese tax identification;
- Proof of address in the Autonomous Region of Madeira (1);

- Copy of the last income tax return and respective payment note or declaration issued by the competent services of the Tax Administration attesting the exemption from filing the income tax return of the household taxpayers;
- Document proving of any of the following social benefits:
  - i. Disability pension;
  - ii. Social disability pension;
  - iii. Social Inclusion Benefit.

### **DISABILITY II SOCIAL PASS » Municipal €25,75/ Intermunicipal €34,35**

Individual monthly pass valid for residents and equivalent residents of the RAM. Applicable to passengers who are beneficiaries of a disability pension due to permanent incapacity for work, whose proven average monthly income is higher than the value of the social support index (currently 522,50€ per month). Valid for routes that do not exceed the fare zones for which it was purchased. Allows unlimited travel, on regular public service routes, except the Aerobus service, operated by any Operator in the RAM.

Submit a copy of the following documents:

- Civil identification card or passport;
- Portuguese tax identification;
- Proof of address in the Autonomous Region of Madeira (1);
- Document proving of any of the following social benefits:
  - i. Disability pension;
  - ii. Social disability pension;
  - iii. Social Inclusion Benefit.

### **RETIRED 0 SOCIAL PASS » Municipal/ Intermunicipal Free**

Individual monthly pass valid for residents and equivalent residents of the RAM. Applicable to retired, under the age of 65, of any Portuguese Social Security system, whose proven average monthly income is equal to or less than 54,15% of the value of the social support index (currently 282,93€ per month). Valid for routes that do not exceed the fare zones for which it was purchased. Allows unlimited travel, on regular public service routes, except the Aerobus service, operated by any Operator in the RAM.

Submit a copy of the following documents:

- Civil identification card or passport;
- Portuguese tax identification;
- Proof of address in the Autonomous Region of Madeira (1);
- Copy of the last income tax return and respective payment note or declaration issued by the competent services of the Tax Administration attesting the exemption from filing the income tax return of the household taxpayers;
- Document proving of any of the following social benefits:
  - i. Solidarity complement for the elderly;
  - ii. Retirement pension.

### **RETIRED I SOCIAL PASS » Municipal €11,35/ Intermunicipal €15,15**

Individual monthly pass valid for residents and equivalent residents of the RAM. Applicable to retired, under the age of 65, of any Portuguese Social Security system, whose proven average monthly income is equal to or less than the value of the social support index (currently 522,50€ per month). Valid for routes that do not exceed the fare zones for which it was purchased. Allows unlimited travel, on regular public service routes, except the Aerobus service, operated by any Operator in the RAM.

Submit a copy of the following documents:

- Civil identification card or passport;
- Portuguese tax identification;
- Proof of address in the Autonomous Region of Madeira (1);

- Copy of the last income tax return and respective payment note or declaration issued by the competent services of the Tax Administration attesting the exemption from filing the income tax return of the household taxpayers;
- Document proving of any of the following social benefits:
  - i. Solidarity complement for the elderly;
  - ii. Retirement pension.

### RETIRED II SOCIAL PASS » Municipal €25,75/ Intermunicipal €34,35

Individual monthly pass valid for residents and equivalent residents of the RAM. Applicable to retired, under the age of 65, of any Portuguese Social Security system, whose proven average monthly income is higher than the value of the social support index (currently 522,50€ per month). Valid for routes that do not exceed the fare zones for which it was purchased. Allows unlimited travel, on regular public service routes, except the Aerobus service, operated by any Operator in the RAM.

Submit a copy of the following documents:

- Civil identification card or passport;
- Portuguese tax identification;
- Proof of address in the Autonomous Region of Madeira (1);
- Document proving of any of the following social benefits:
  - i. Solidarity complement for the elderly;
  - ii. Retirement pension.

### 30 DAYS PASS <sup>(2)</sup> » Municipal €40/ Intermunicipal €50

Individual pass valid for 30 consecutive days from the date of top up, applicable to passengers who do not present proof of residence in the RAM. Valid for routes that do not exceed the fare zones for which it was purchased. Allows unlimited travel, on regular public service routes, except the Aerobus service, operated by any Operator in the RAM.

Submit a copy of the following documents:

- Civil identification card or passport;
- Portuguese tax identification.

Note:

(1) Proof of address in the Autonomous Region of Madeira (RAM):

- i. Proof of tax residence;
- ii. Document issued by Portuguese public entities stating that the holder has habitual residence in the Autonomous Region of Madeira, in the event that the document proving identity does not contain this information or it is not possible to access it electronically;
- iii. Registration certificate or certificate of permanent residence, if a citizen of the European Union, in accordance with articles 14 and 16 of Law No. 37/2006, of August 9, amended by Law No. 41/2023, of June 2;
- iv. Temporary residence card or permanent residence card, in the case of a family member of a European Union citizen, third-country national, in accordance with articles 15 and 17 of Law no. 37/2006, of 9 August, amended by Law No. 41/2023, of June 2;
- v. Valid residence permit in RAM, if a national citizen of a State that is not a member of the European Union and to which articles 15 and 17 of Law No. 37/2006, of August 9, amended by Law No. 41/2023, of June 2, are not applied.

#### Fare zone:

The fare zone comprises 4 types of zones:

**a) Municipal:** covers trips that do not exceed the geographical area of the Municipality for which it was acquired, in all Public Service routes, except aerobus service, of the operator or operators serving that municipality in RAM;

**b) Intermunicipal:** covers trips throughout the Madeira island and the Porto Santo island, in all Public Service routes, except the aerobus service, of any operator in RAM.

**c) Regional:** covers trips throughout the Madeira island and the Porto Santo island, in all Public Service routes of any operator in RAM, including aerobus service;

**d) Aerobus:** covers trips on the aerobus service to and from Madeira international airport that are included in this service.

The emission of the GIRO pass card costs €5.

The emission of the GIRO pass card and profile update/revalidation can be made at HF sales and information offices – Anadia, Pinga or Marina, for residentes in Funchal and Curral das Freiras.

The 30 days pass can be issued at any operator sales office: HF, CAM and SIGA Rodoeste.
