



TICKETS:

ON BOARD TICKET » €1,95

Valid on the journey of purchase. Allows a single journey.

PREPAID TICKET (Adult) ⁽¹⁾

From 2 to 9 journeys	€1,35/each
From 10 to 31 journeys	€1,25/each

This prepaid ticket can be recharged from 2 journeys (minimum) up to 31 journeys and can be reused as many times as you like.

PREPAID TICKET (Children) ⁽¹⁾ » €0,70/cada

For children aged from 6 and 12 years old. This prepaid ticket can be recharged from 2 journeys (minimum) up to 31 journeys and can be reused as many times as you like.

GROUPS TICKET (Adult or Children) ⁽¹⁾

Number of passengers x prepaid ticket price x 1 (1 journey)
Number of passengers x prepaid ticket price x 2 (2 journeys)

Ticket suitable for groups (adults or children) that intend to make 1 or 2 journeys. The group must assign a person who will be responsible for presenting the ticket receipt to the driver for validation.

Sold exclusively at HF sales and information offices.

Note: For children aged from 6 and 12 years old. The responsible person shall, upon acquisition, present a copy or original of the identification Documents to confirm the ages.

1, 3, 5 AND 7 DAY TICKET ⁽¹⁾

1 Day	€4,50	5 Days	€16,50

Valid for 1, 3, 5 or 7 days (counting from the time of first validation). Allows unlimited travel in any route of the urban service.

GIRO 24 - COMBINED TICKETS (Urban + Interurban) ⁽¹⁾

1 Day (Adult)	€12,50	1 Day (Children)	€8,50

Valid for 24 hours, counting from the time of first validation. Allows unlimited travel in any route of the urban and the interurban service. For children aged from 6 and 11 years old.

Sold at HF sales and information offices, HF Tourist office, Carristur Stores and Tourist Kit Post.

⁽¹⁾The card GIRO Ticket is paid only in the first purchase and it costs €0,50. All GIRO Tickets are not personalized because they can be transferable. However, once on board, each passenger must have one. Keep it, don't throw away, you can recharge it with more journeys.

PASSES:

GIRO pass card request:

- 1 recent passport-type photo;
- price €5.

GIRO TOURIST 15 URBAN » €30

Valid during 15 consecutive days, starting from the date that is defined

in the moment of purchase. Allows unlimited travel in any route of the urban service.

Document:

- Civil identification card, passport or other identification card with photo.

The first purchase can only be made in the HF's Sales (Marina, Anadia or Pinga), and it is valid from the date that the customer requires it. The next purchases:

- » With a start date pre-defined, it can only be made in the HF's Sales;
- » With the start date on the same day of purchase, it can be made in HF's Sales and HF vending machines;
- » With the start date on the next day of purchase, it can be made in HF's Sales, Payshop's Agents, and Post offices.

SOCIAL PASS » €30

Individual monthly pass. Allows unlimited travel in any route of the urban service.

Documents:

- Civil identification card;
- Tax identification card;
- Proof of tax address in the Autonomous Region of Madeira through the Certificate of Domicile Tax (Finance) or the Declaration of Residence issued by the Parish.

SOCIAL PASS 4_23 » Free

Valid for students enrolled in a school of the Autonomous Region of Madeira until the month that turns 24 years old. Allows unlimited travel in any route of the urban service.

Documents:

- Civil identification card;
- Tax identification card;
- Declaration from the education institution confirming that the student is enrolled in the current academic year.

Sold exclusively in the HF's Sales - Anadia.

Social pass 4_23 is valid (if requirements are maintained) until the date indicated on the charging receipt or GIRO cards laminated, without the need to top up.

STUDENT SOCIAL PASS +23 » €22,50

Individual monthly pass. For students aged 24 years old or over enrolled in a school of the Autonomous Region of Madeira. Allows unlimited travel in any route of the urban service.

Documents:

- Civil identification card;
- Tax identification card;
- Declaration from the education institution confirming that the student is enrolled in the current academic year.

SOCIAL PASS +65 » Free

For passengers aged 65 years old or over. Allows unlimited travel in any route of the urban service.

Documents:

- Civil identification card;
- Tax identification card;

- Proof of tax address in the Autonomous Region of Madeira through the Certificate of Domicile Tax (Finance) or the Declaration of Residence issued by the Parish.

Sold exclusively in the HF's Sales - Anadia.

Social pass +65 is valid until the date indicated on the charging receipt or GIRO cards laminated, without the need to top up.

FORMER COMBATANT SOCIAL PASS » Free

Applicable to former combatants, or their widowers, holders of the card defined in articles 4 and 7 of the Statute of the Former Combatant, currently regulated by Ordinance No. 210/2020, of 3 September. Allows unlimited travel in any route of the urban service.

Documents:

- Civil identification card;
- Tax identification card;
- Former combatant or widowers former combatant card.

Sold exclusively in the HF's Sales - Anadia.

Former Combatant Social pass is valid until the date indicated on the charging receipt or GIRO cards laminated, without the need to top up.

DISABILITY 0 SOCIAL PASS » Free

Applicable to passengers who are beneficiaries of a disability pension due to permanent incapacity for work, whose proven average monthly income is equal to or less than €260,16 per month. Allows unlimited travel in any route of the urban service.

Documents:

- Civil identification card;
- Tax identification card;
- Proof of tax address in the Autonomous Region of Madeira through the Certificate of Domicile Tax (Finance) or the Declaration of Residence issued by the Parish;
- Copy of the last income tax return and respective payment note or declaration issued by the competent services of the Tax Administration attesting the exemption from filing the income tax return of the household taxpayers;
- Document proving the ownership of a social disability pension.

Disability 0 Social pass is valid until the date indicated on the charging receipt or GIRO cards laminated, without the need to top up.

DISABILITY I SOCIAL PASS » €11,35

Individual monthly pass. For passengers who are beneficiaries of a disability pension due to permanent incapacity for work, whose proven average monthly income is equal to or less than the value of the social support index (€509,26 in 2024). Allows unlimited travel in any route of the urban service.

Documents:

- Civil identification card;
- Tax identification card;
- Proof of tax address in the Autonomous Region of Madeira through the Certificate of Domicile Tax (Finance) or the Declaration of Residence issued by the Parish;
- Copy of the last income tax return and respective payment note or declaration issued by the competent services of the Tax Administration attesting the exemption from filing the income tax return of the household taxpayers;

DISABILITY II SOCIAL PASS » €25,75

Individual monthly pass. For passengers who are beneficiaries of a disability pension due to permanent incapacity for work, whose proven average monthly income is higher than the value of the social support index (€509,26 in 2024). Allows unlimited travel in any route of the urban service.

Documents:

- Civil identification card;
- Tax identification card;
- Proof of tax address in the Autonomous Region of Madeira through the Certificate of Domicile Tax (Finance) or the Declaration of Residence issued by the Parish;
- Document proving the ownership of a social disability pension.

RETIRED 0 SOCIAL PASS » Free

Applicable to retired of any Portuguese Social Security system, whose proven average monthly income is equal to or less than €260,16 per month. Allows unlimited travel in any route of the urban service.

Documents:

- Civil identification card;
- Tax identification card;
- Proof of tax address in the Autonomous Region of Madeira through the Certificate of Domicile Tax (Finance) or the Declaration of Residence issued by the Parish;
- Copy of the last income tax return and respective payment note or declaration issued by the competent services of the Tax Administration attesting the exemption from filing the income tax return of the household taxpayers;
- When applicable, document proving ownership of any of the following social benefits:

Retired 0 Social pass is valid until the date indicated on the charging receipt or GIRO cards laminated, without the need to top up.

RETIRED I SOCIAL PASS » €11,35

Individual monthly pass. Applicable to retired of any Portuguese Social Security system, whose proven average monthly income is equal to or less than the value of the social support index (€509,26 in 2024). Allows unlimited travel in any route of the urban service.

Documents:

- Civil identification card;
- Tax identification card;
- Proof of tax address in the Autonomous Region of Madeira through the Certificate of Domicile Tax (Finance) or the Declaration of Residence issued by the Parish;
- Copy of the last income tax return and respective payment note or declaration issued by the competent services of the Tax Administration attesting the exemption from filing the income tax return of the household taxpayers;
- When applicable, document proving ownership of any of the following social benefits:
 - Solidarity complement for the elderly;
 - Social old age pension;
 - Retirement pension.

RETIRED II SOCIAL PASS » €25,75

Individual monthly pass. Applicable to retired of any Portuguese Social Security system, whose proven average monthly income is higher than the value of the social support index (€509,26 in 2024). Allows unlimited travel in any route of the urban service.

Documents:

- Civil identification card;
- Tax identification card;
- Proof of tax address in the Autonomous Region of Madeira through the Certificate of Domicile Tax (Finance) or the Declaration of Residence issued by the Parish;

- When applicable, document proving ownership of any of the following social benefits:
 - o Solidarity complement for the elderly;
 - o Social old age pension;
 - o Retirement pension.

COMBINED SOCIAL PASS (FUNCHAL/ INTERMUNICIPAL) »
€21,85**

Individual monthly pass. For passengers that need to use the transport service provided by interurban transport company and urban transport company in Funchal. Allows unlimited travel in any route of the urban service. The interurban pass card must have valid stickers, or any other means of control, for the interurban and the urban service. Allows unlimited travel in any route of the urban service.

Sold at intermunicipal transport operator's sales offices.

** Free if the user holds a free interurban pass.

Note:

Social passes are non-transferable and issued until 12 months from the date of issue of the respective profile, renewable, if applicable, upon proof that the requirements for its attribution are maintained.

The issuance of the GIRO pass card is available at HF's Sales – Anadia and Pinga, with immediate delivery. In the case of free passes, issuance is available at Anadia.

The renewal or update of the profile (type of pass) in the GIRO Pass card can only be made in the HF's Sales (Marina, Anadia ou Pinga).

The validity period starts when the Card is issued:

- Children aged from 4 and 12 years old, the validity is 3 years;
 - From 13 years old, the validity is 4 years.
